The “Why?”

Contentiful creates, posts, and maintains digital content for federal agencies, so it is important to understand Section 508 requirements and how they apply to the organizations we serve and support. Contentiful shares digital documents with federal employees and develops content for federal government websites, so it is important to know how to make digital content accessible. By understanding and implementing Section 508, Web Content Accessibility Guidelines (WCAG), and Plain Language requirements properly, Contentiful helps ensure people with disabilities have equal access to information and communication technology (ICT), and that we comply with all legal requirements for accessibility.

Section 508 Defined

Section 508 amends the Rehabilitation Act of 1973 related to ICT (<https://www.access-board.gov/ict/>). Section 508 mandates that federal government ICT must comply with specific standards designed to improve accessibility.

Section 508 specifically established requirements so that any time a federal government agency "procured, developed, maintained, or used" ICT, **the technology must be usable by people with disabilities**. This law applies to technology used by federal government employees and members of the public who use federal government technology. The federal government established Section 508 to eliminate barriers to technology, **provide equal (or comparable) access to people with disabilities**, and require the development of accessible technology. This law has been revised and updated multiple times, most recently in 2018, to ensure the written standards align with the intended purpose of Section 508.

ICTs: computer software and hardware (desktops, mobile devices), kiosks, telephones, printers, scanners, faxes, websites, electronic documentation.

Accessible documents

Focus on readability

We use a WCAG 2.1-compliant color contrast analyzer to validate the contrast ratios for text, graphical objects, and foreground/background color conform to accessibility standards.
